*Somerhill is a registered early years free entitlement (EYFE) provider for 3 and 4-year-olds. All children (from the term following their 3rd birthday until the term of their 5th birthday) are eligible to receive a maximum of 15 hours per week for 38 weeks of the year, regardless of parental income. Parents are only able to claim for the number of full weeks in our academic year as designated by Kent County Council (KCC). Parents who do not use their full 15 hours may claim the difference through another registered provider. Please note that for children to be eligible for the EYFE funding discount, they must be in school between 9.25 - 12.25. Parents only wishing to access 15 hours EYFE will be offered 5 sessions from 9.25 - 12.25, subject to availability, until compulsory school age. Somerhill reserves the right to withdraw from the scheme at any time and will endeavour to give one term's notice of any change.

** Depends on the length of term and number of full weeks eligible at 15 hours per week for EYFE and will be pro-rated depending on the number of sessions opted for. The lowest fee is for the Michaelmas Term and assumes full receipt of 15 hours maximum EYFE during specified sessions. Fees will be adjusted in arrears to reflect actual amounts paid by KCC and sessions attended.

Fees are fully inclusive except for school lunches (charged at £258 per child per term), learning support tuition, individual music tuition, hire of musical instruments, recreational and overseas trips, minibus service to and from Somerhill, and external examination fees.

All fees are stated exclusive of VAT.

Sibling discounts

There is a 5% reduction of fees for a second child and a 10% reduction for the third or fourth child when three or more children are at Somerhill. Discounts will be reduced as the elder siblings leave Somerhill.

Payment of fees

Fees are due for payment before the first day of term unless otherwise agreed by a separate contractual arrangement. Somerhill reserves the right to levy a late payment charge on all fees unpaid after the first day of term. Fees are paid at the beginning of each term by direct debit or by a separate arrangement under our Termly Direct Debit Scheme. We also operate an advance fees scheme. Withdrawal of pupil

The agreement for a pupil's education at Somerhill may be terminated by giving a full term's notice in writing or on payment of a full term's fees in lieu of such notice.
